- Specific requirements for suppliers of chemical products and hazardous substances:
 - Supply only products that meet applicable safety and environmental standards, prioritizing and informing about less polluting alternatives.
 - Provide an updated Safety Data Sheet for the supplied products.
- Specific requirements for vehicle and machinery workshops and technical services:
 - Manage hazardous waste generated in accordance with current regulations.
 - Provide waste producer number.
- Specific requirements for transportation companies and services:
 - Provide transportation services for materials in compliance with current motor vehicle emissions regulations.
 - Drive efficiently and safely to minimize emissions and fuel consumption.
- Specific requirements for machinery rental companies:
 - Machinery must have CE marking in Europe or comply with legal or final client requirements in other regions.
